• News from Chalmers Neighbourhood Renewal Corporation (Dale Karasiak)

- o Information was presented on the plans for the vacant lot located at the corner of Henderson Highway and Johnson Avenue West. The Chalmers Neighborhood Renewal Corporation is hoping to working with the property owners (Suncor) to re-develop the area into a community meeting area with gardens.
- Call for submissions to Glenelm Business Directory (Kara Plett)
 - Individuals with home based businesses were invited to submit their information for the development of an online business directory. The directory will be available on the new GeNA website.
- Local Area Plan update (Brock Feenstra)
 - A small working group has met with The City of Winnipeg to discuss a Local Area Plan for the Glenelm and Chalmers Neighborhood. Community members will be solicited for their input in the coming months.
- Upcoming events (Arlene Reid)
 - Arlene shared information on events from the church, CNRC, ECRC and the Glenelm Cemetery.

- "Welcome to Glenelm" Sign Project update (Joanne Cerilli/Emma Durand-Wood)
 - O Joanne Cerilli and Rosalie Block have been approaching community members asking for monetary donations for a fund needed to maintain the proposed neighborhood signs. Councillor Schreyer's Office has agreed to pay for the physical signs, but a pool of money is required to ensure sign maintenance. The fund needs to be established before the sign can be affix on the hydro poles. Information on the signs and a donation jar was available during the meeting.
- Safety Committee info (Shauna MacKinnon)
 - O At the October 3, 2016 community meeting there was significant discussion regarding safety in our community. Individuals spoke about their experiences of property damage (i.e. vandalism and graffiti) and theft (i.e. garage and car break-ins). There was also interest express in starting a volunteer foot patrol for the neighborhood. As a result a Safety Committee is being formed. Individuals interested in working on this community were encouraged to add their names to the sign-up sheet or contact Shauna MacKinnon via the GeNA website.
